NOTICE OF RACE

ORGANISING AUTHORITY: Plimmerton Boating Club

1.0 Rules

- 1.1 The regatta will be governed by the 'rules' as defined in the Racing Rules of Sailing.
- 1.2 The Yachting New Zealand Safety Regulations, Part 1 shall apply to all unballasted Centreboard and Open Yachts.
- 1.3 For protests where only a Rule of Part 2 or Rule 31 is alleged to have been broken an arbitration hearing will be offered prior to any formal hearing.

2.0 Eligibility and Entry


- 2.1 The regatta is open to all Centreboard Classes
 Opti Rainbow, Opti Green, Opti Open, Open BIC, P Class, Starling, Laser, Z
 Class, Paper tiger, 29er, Waszp, Zephyr
- 2.2 To be eligible to compete in this event each entrant and crew shall be a financial member of a club recognised by the entrant and crew member's national authority.
- 2.3 Entries will be taken from 8.30am the Sunday 31st March 2019.

3.0 Entry Fees

3.1 All Classes \$15-00 per boat

4.0 Schedule

- 4.1 Registration and entry 0830 hours to 0930 hours
- 4.2 Briefing 0930 hours
- 4.3 The scheduled time of the warning signal for the first race is 1030 hours.
- 4.4 Upto 4 races are scheduled for all Classess

6.0 **Racing Areas**

6.1 On the waters adjacent to Plimmerton Boating Club.

7.0 The Courses

7.1 Courses may be triangular and or windward/leeward.

8.0 **Penalty System**

8.1 For all classes, rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

9.0 Scoring

- 9.1 The Low Points scoring system of Appendix A will apply except as changed below.
- 9.2 4 races are scheduled, of which one race is required to be completed to constitute a series.
- 9.3 A boat's series score will be the total of all her race scores.

10.0 **Prizes**

10.1 The Award-giving Presentation will be held on Sunday 31st March at approximately 1700 hours or after all matters are decided.

10.0 **Disclaimer of Liability**

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The Organising Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
