1.1	The regatta will be governed by the 'rules' as defined in the Racing Rules of Sailing 2017-2020 and the Laser class rules
1.2	The Yachting New Zealand Safety Regulations Part 1 will apply.
1.3	For protests where only a rule of Part 2, When Boats Meet, or rule 31, Touching a Mark, is alleged to have been broken, an arbitration hearing may be offered prior to any formal protest hearing.
2	ADVERTISING
2.1	The Organising Authority may require all participating boats to display the event sponsor's advertising in accordance with ISAF Regulation 20, Advertising Code.
3	ELIGIBILITY AND ENTRY
3.1	The regatta is open to all boats of the Laser, Laser Radial & Laser 4.7 classes
3.2	Eligable boats may enter by completing the attached form and sending it, together with the required fee to The Secretary Ravensbourne Boating Club 3 Taupo Street Ravensbourne Dunedin 9022, by 12 th November 2019 Entries can be emailed to secretary@ravensbourne.co.nz and payment by direct credit to; 0109070010944-00 (tag "SILaser" plus Sail No")
3.3	Late entries, accompanied by an additional fee of \$30.00 may be accepted until close of registration on Saturday 19 th November 2019. No entries will be accepted after this time.
3.4	To be eligible to compete each competitor shall be a financial member of a club recognised by their national authority and shall be a member of a club recognised by Yachting New Zealand.

5.2	Dates of racing: 30 th November All Classes 1 st December All Classes
5.3	Number of races: 3 back to back races each day are scheduled, a maximum of 4 races may be sailed on Saturday in which case 2 races will be sailed on the Sunday.
6	RACING AREA
6.1	Based at Vauxhall Yacht Club .
6.2	All races will be sailed on Upper Otago Harbour
7	LAUNCHING
7.1	Unless otherwise directed by the Organising Authority, all competing boats will be launched and retrieved from the Vauxhall Yacht Club.
8	RADIO COMMUNICATION
8.2	Except in an emergency, a boat shall while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.
