### **NOTICE OF RACE**

#### **1 RULES**

**1.1** The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* and the Class Rules

**1.2** The Yachting New Zealand Safety Regulations Part 1 shall apply.

**1.3** Racing rule A4.1 will be changed to 'a boat starting later than 4 minutes after starting signal will be scored DNS'  
Racing rule 27.1 will be changed to no later than the Preparatory the race committee signal boat will display the course number.

The changes will appear in full in the sailing instructions. The sailing instructions may also change other racing rules.

**1.4** Appendix T, Arbitration will apply

## **2 ADVERTISING**

Boats may be required to display advertising chosen and supplied by the organizing authority.

## **3 ELIGIBILITY AND ENTRY**

**3.1** The regatta is open to all centreboard classes.

**3.2** Eligible boats may enter by completing the attached form and sending it, together with the required fee.

Single sailor       \$40.00

One day             \$20.00

Family             \$40.00 plus \$30.00 for each additional boat

All double crewed boats \$60.00

**3.3** Late entries may be accepted with an additional \$5 late entry fee until 0930hrs Saturday 29<sup>th</sup> February 2020.

**3.4** To be eligible to compete in this event each competitors and crews shall be a financial member of a club recognised by the competitors national authority

## **4 SCHEDULE**

**4.1** Registration:

Saturday 29<sup>th</sup> February 2020 From 0830hrs To 0930hrs

**4.2** Briefing:

Saturday 29<sup>th</sup> February 2020 0945 hrs.

**4.3** Racing Schedule:

The scheduled time of the warning signal for race 1 is 1055 hours on Saturday 29<sup>th</sup> February 2020.

The scheduled time of the first warning signal on Sunday  
1<sup>st</sup> March 2020 is 1025 hours.  
3 races are scheduled per day.  
A total of 6 races are scheduled.

**4.4** No race shall start after 1500 hours on Sunday 1<sup>st</sup> March 2020.

## **5 MEASUREMENTS**

Each boat must comply with the class rules and measurement requirements.

## **6 SAILING INSTRUCTIONS**

The sailing instructions will be available at registration.

## **7 VENUE**

**7.1** The Tauranga Yacht & Power Boat Club (inc) At the end of Sulphur Point Tauranga.

**7.2** Racing Area is the inner Tauranga Harbour.

## **8 THE COURSES**

The courses to be sailed will be as follows: triangle, windward/leeward or windward/leeward.

## **9 SCORING**

**9.1** The Low Point System of Appendix A will apply.

**9.2** Two races are required to be completed to constitute a series.

**9.3** (a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.

(b) When 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

## **10 SUPPORT BOATS**

Support boats shall be marked with the Burgee of the club they represent.

**11 LAUNCHING**

Unless otherwise directed by the Organising Authority, all competing boats and equipment shall be launched and retrieved from in front of the TYPBC club house.

**12 RADIO COMMUNICATION**

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

**13 PRIZES**

Prizes will be awarded at the conclusion of the regatta.

**14 DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See rule 4 Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta,
