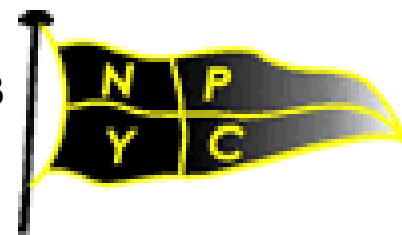

## **NOTICE OF RACE**

### **1 The Organizing Authority**

1.1 The organising authority is the New Plymouth Yacht Club, Ocean View Parade, New Plymouth.

### **2 Rules**

- 2.1 The regatta will be governed by the 'rules' as defined in the Racing Rules of Sailing.  
2.2 The Yachting New Zealand Safety Regulations Part 1 shall apply.

### **3 Changes to Racing Rule**

### **4 Eligibility and Entry**

- 4.1 The regatta is open to all Finn class that comply with their Class Rules.  
4.2 Entries will be accepted between 0800hrs and 0900hrs on Saturday 21<sup>st</sup> November 2020 by completing the attached entry form accompanied by a fee of \$50.00.  
4.3 To be eligible to compete in this event each competitor shall be a financial member of a club recognized by Yachting New Zealand.

## **6 Prize giving**

6.1 Prize giving will be held as soon as possible after completion of racing on Sunday.

## **7 Sailing Instructions**

7.1 The amended NPYC Sailing Instructions will apply. Copies be available at registration.

## **8 Racing Area and Courses**

8.1 The races will be held in the vicinity of Port Taranaki.

8.2 The courses may be windward leeward or triangle windward/leeward or a combination thereof.

## **9 Alternative Penalties**

9.1 Refer NPYC sailing instructions

## **10 Scoring**

10.1 One race is required to be completed to constitute a series.

10.2 When fewer than 7 races have been completed, a boat's series score will be the total of her race scores.

10.3 When 7 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

## **11 Prizes**

11.1 1st, 2nd, and 3rd prizes will be awarded.

## **12 Launching**

12.1 All dinghies' must be launched and retrieved from the beach in front of the New Plymouth Yacht Club.

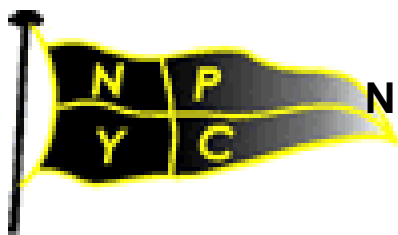
## **13 Disclaimer of Liability**

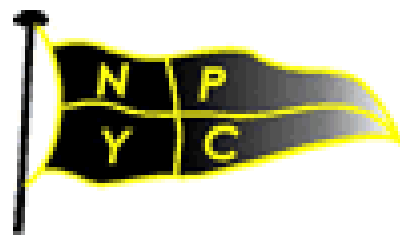
