NOTICE OF RACE

NB: The notation '[DP]' in a rule in the Notice of Race means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

1 RULES

- **1.1** The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 The Yachting New Zealand Safety Regulations

Hartley 16 & Flying Fifteen, Part 1 shall apply.

Noelex 25, Part V category C shall apply, upgraded so that all boats competing must carry a VHF radio transceiver capable of receiving and transmitting VHF channel 77, a minimum of 5 litres of fuel each day of the regatta, and an operational outboard engine rated at not less than 8HP.

1.3 Class Rules for **Noelex 25 Trailer Yacht Association (N25TYA), Hartley 16 & Flying Fifteen** will apply to all yachts competing in their corresponding Fleet.

1.4 Racing rules

A boat that does not start within four minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A4 and A5.

The Sailing Instructions may change other racing rules.

1.5 Appendix T, Arbitration, will apply.

2 ADVERTISING

2.1 Boats may be required to display advertising chosen and supplied by the Organising Authority. If this rule is broken, World Sailing Regulation 20.9.2 applies. [DP]

3 ELIGIBILITY AND ENTRY

- **3.1** The regatta is open to all boats of the **Noelex 25 Trailer Yacht**, **Hartley 16 & Flying Fifteen** classes whose owners are current financial members of their National Class Association.
- Eligible boats may enter by completing the attached form and emailing to manager@napiersailingclub.org.nz.
 Payment to be made electronically to Napier Sailing Club by 1700hrs, 26th February 2021.

- **3.3** Late entries accompanied by the contest entry fee plus the late entry fee may be accepted at the race committee's discretion until 1700 hrs. 4th March 2021.
- **3.4** To be eligible to compete in this event each Skipper and crew member(s) shall be a financial member of a club recognised by the Skipper and crew member's national authority.

Proof of affiliated club membership shall be presented at registration.

5.4 Number of races: 9 Races are scheduled.

5.5 On the last scheduled day of racing no warning signal will be made after 1530hrs.

6 MEASUREMENT

- **6.1** Each boat shall produce a valid measurement certificate. In addition, Boat Weight and other Measurements may be taken to ensure boats meet Class Rules and Safety Regulations. Any sails not previously signed will be required to be measured.
- **6.2** A boat shall comply with RRS 78.1 throughout the contest and may be checked at any time during the event.
- **6.3** A Peer Review Safety Checklist & Safety Declaration is to be completed at registration. NB; a safety check may be made on any boat at any time during the event.

7 SAILING INSTRUCTIONS

The Sailing Instructions will be available after on Monday 01 February 2021 from the Napier Sailing Club website

8 VENUE

- **8.1** Attachment A; shows the location of the regatta venue.
- 8.2 Attachment B; shows the location of the racing area.

9 THE COURSES

The courses to be sailed will be as follows: Windward / Leeward, Triangles or a mixture of both.

10 PENALTY SYSTEM

10.1 For ALL classes RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

11 SCORING

11.1 5 races are required to be completed to constitute a series.

11.2

- a) When fewer than 6 races have been completed, a boat's series score will be the total of her race scores.
- b) For Hartley 16 & Flying Fifteen,
- When 6 to 9 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- c) For **Noelex 25** only;
- When 6 to 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- When 9 or more races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

12 SUPPORT BOATS

Support boats shall Register with the Organising Authority. [DP]

13 BERTHING

Boats shall be kept in their assigned places while they are in the boat park. [DP]

14 LAUNCHING & RETRIEVAL RESTRICTIONS

Competitors shall launch and retrieve vessels from Napier Sailing Club ramps during the regatta, except with and according to the terms of, prior written permission of the race committee. [DP]

15 RADIO COMMUNICATION

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. This restriction also applies to mobile telephones. [DP]

16 PRIZES

Prizes may be awarded at the discretion of the Organising Authority in conjunction with the Class Association.

17 INSURANCE

Each participating boat should be insured with valid marine third-party liability insurance with a minimum cover of \$1,000,000 per incident or the equivalent.

18 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organising authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

19 Event Cancellation

In the event of cancellation due to any causes outside of the Organising Authority's control, all efforts will be made to reimburse Entry fees minus any Event associated cost already incurred that are not recoverable.
