



New Zealand Youth Championships 2021

Notice of Race (NoR)

The New Zealand Youth Championships will be held at Royal Akarana Yacht Club, 2nd-6th October 2021.

The Organising Authority is Yachting New Zealand.

The event is run as a selection for the 2021 New Zealand Youth Sailing Team.

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a). The notation '[DP]' in a rule denotes a rule for which the penalty is at the discretion of the Protest Committee. The notation '[SP]' denotes a rule for which a standard penalty may be applied by the race committee without a hearing.

1 RULES

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 The Yachting New Zealand Safety Regulations Part 1 shall apply.
- 1.3 RRS Appendix P, Special Procedures for Rule 42, will apply.
- 1.4 The prescriptions of Yachting New Zealand will apply.

2 SAILING INSTRUCTIONS

3 COMMUNICATION

- 3.1 The online official notice board is located at <https://www.yachtingnz.org.nz/>
- 3.2 [DP] While racing except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

- 4.1** All competitors shall be under the age of 19 years on 31 December 2021.
- 4.2** Boats may enter the event by registering online at www.yachtingnz.org.nz.
- 4.3** To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.4** No entries will be accepted after 19th September 2021.
- 4.5** To be eligible to compete in this event each competitor shall be a financial member of a yacht club affiliated to Yachting New Zealand.
- 5 FEES**
- 5.1** Each competitor will be charged an entry fee of NZL \$150 per sailor, payable to the organising authority as instructed on the entry form.
- 5.2** There will be no refund if entered competitors withdraw their entry after the entry deadline.
- 6 ADVERTISING**
- 6.1** Boats may be required to display advertising chosen and supplied by the organizing authority.
- 6.2** The organizing authority may provide bibs that competitors are required to wear as permitted by the World Sailing Advertising Code.

7 FORMAT

7.1 The regatta will consist of a single series

7.2 The Boy's One Person Dinghy and Girl's One Person Dinghy shall race and be scored as one fleet.

The Boy's Windfoil and Girl's Windfoil events shall race and be scored as one fleet.

The Boy's Skiff and Girl's Skiff shall race and be scored as one fleet.

The Girl's Kitefoil and Boy's Kitefoil shall race and be scored as one fleet.

8.2 On the last scheduled day of racing no warning signal will be made after 1500.

9 EQUIPMENT INSPECTION

9.1 All boats will require a valid measurement certificate with all equipment presented having been premeasured. Class rules as on the World Sailing website as of 2nd October 2021 will apply. A boat or board may be inspected at any time for compliance with the rules.

10 VENUE

10.1 NoR Addendum A shows the location of the racing areas.

11 COURSES

11.1 The courses will be Windward/Leeward or Trapezoid.

12 PENALTY SYSTEM

12.1 For the Boy's Skiff, Girl's Skiff, Mixed Two Person Multihull, Girl's Windfoil, Boy's Windfoil, Boy's Kitefoil and Girl's Kitefoil RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12.2 RRS Appendix P, Special Procedures for Rule 42, will apply.

13 SCORING

13.1 At least 5 races are required to be completed to constitute a regatta. When 5 or more races have been completed, a boat's series score will be the total of her race scores excluding their worst score.

13.2 After all racing has finished and the results are finalised, the highest placed boy and the highest placed girl in each fleet will be ranked first, and so on to calculate event placings. Except the Mixed Multihull where the highest placed boat will be ranked first.

14. Coach vessels, Support vessels and Spectators

14.1 The intention is to simulate a World Youth Championships where there are no private coach vessels on the water.

14.2 Spectator vessels are allowed but they must register with the organizing authority and agree to provide extra on water safety if deemed necessary or called upon by the OA.

14.3 [DP]Contact between sailors and spectators on the water is prohibited.

14.4 The OA will provide official race support vessels to carry sailor's food bags and spares.

15 CHARTERED OR LOANED BOATS

- 15.1** A chartered or loaned boat may carry national letters or a sail number in contravention of her class rules, provided that the race committee has approved her sail identification before the first race.

16 BERTHING

- 16.1** [DP] Boats shall be kept in their assigned area in the boat park except for Windfoil and Kitefoil classes.

17 Drug Testing

- 17.1** Drug testing may take place during this event.

18 COVID 19 STATEMENT

- 18.1** Decision making on the event in relation to Covid-19 Alert Levels will be made according to the Auckland COVID status as follows: Level 4 – Event will be cancelled Level 3 – Event will be cancelled Level 2 – Event will go ahead with precautions. Level 1 – Event will go ahead with precautions.
- 18.2** If any region other than Auckland is subject to Covid-19 Alert Level 3 or higher, competitors from that region will not be able to travel to the event. The number of competitors unable to travel, and the overall viability of the event will be factored into the decision whether to cancel the event or not. If any region that a competitor is entered from is at a higher Alert Level than Auckland, all competitors and families from that region will be required to consider themselves still under that Alert Level, and precautions will be taken to ensure the segregation and physical distancing of those competitors and families.
- 18.3** If it becomes necessary to cancel the event, payments made to YNZ by competitors in relation to the event will be refunded.

19 Media Rights, Cameras and Electronic Equipment

- 19.1** By participating in the Yachting New Zealand Youth Trials 2021 competitors automatically grant to the organising authority, Yachting New Zealand, and their sponsors, the right in perpetuity to make, use and show, from time to time at their discretion, any still picture, motion pictures and live, taped, or filmed television and other reproductions of the athlete during the period of the competition without compensation.

19.2 Competitors may be required for interviews at the regatta.

20 RISK STATEMENT

20.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**

21 INSURANCE

21.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,000,000 per incident or the equivalent. Certificate of insurance is to be presented at registration.

22 PRIZES

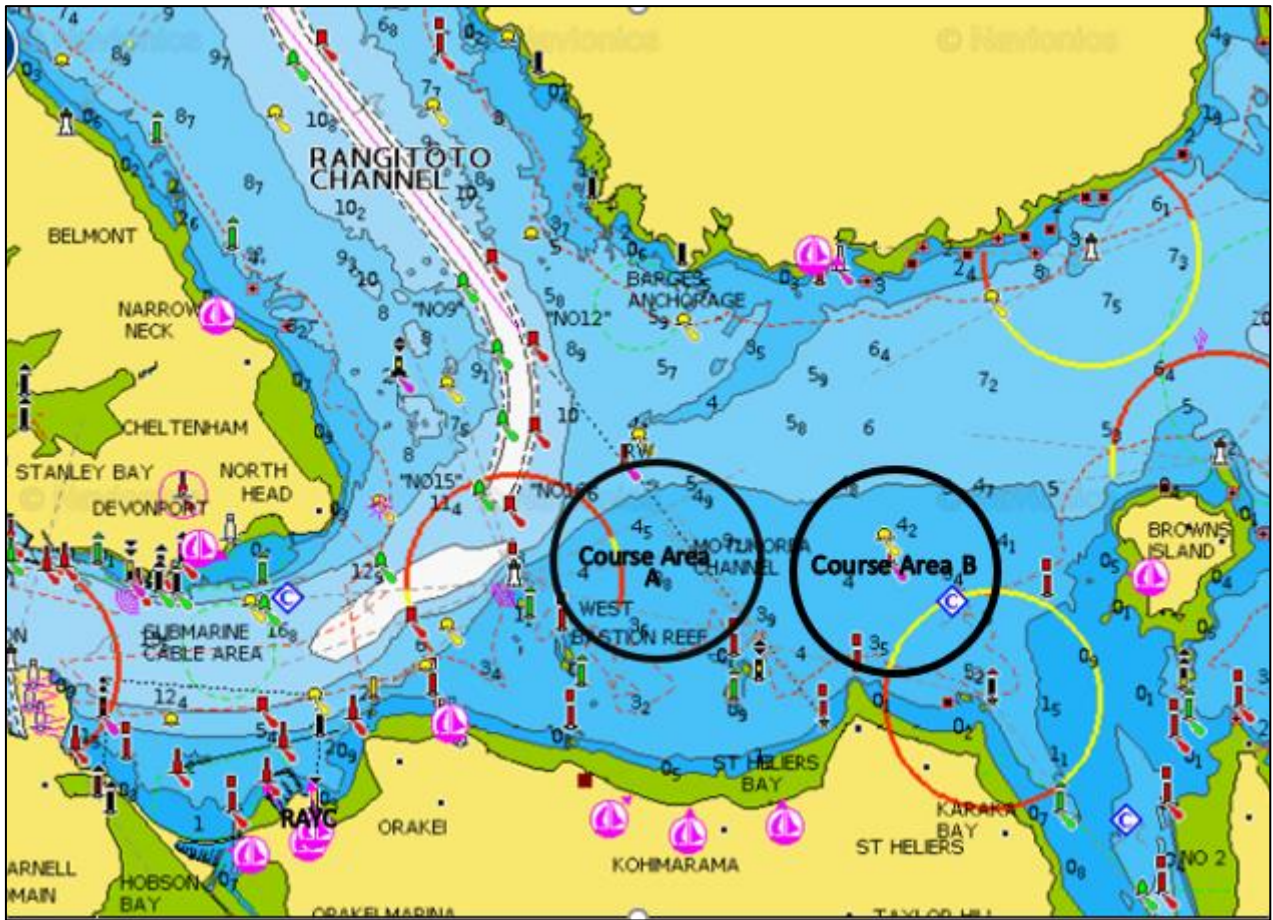
22.1 Prizes shall be awarded to winners of each event.
