Covid-19 example clauses for Race Documents

CORONA VIRUS STATEMENT

Decision making on the event in relation to Government Covid-19 Alert Levels will be made according to the local <*Region*> status as follows:

Level 4 – Event will be cancelled.

Level 3 – Event will be cancelled.

Level 2 – Event will be go ahead with precautions.

Level 1 – Event will be go ahead with precautions.

If any region other than <Region> is subject to Covid-19 Alert Level 3 or higher, competitors from that region will not be able to travel to the event. The number of competitors unable to travel, and the overall viability of the event will be factored into the decision whether to cancel the event or not.

If any region that a competitor is entered from is at a Alert Level than <*Region*>, all competitors and families from that region will be required to consider themselves still under that Alert Leve, and precautions will be taken to ensure the segregation and physical distancing of those competitors and families.

If it becomes necessary to cancel the event, payments made to *Club>* by competitors in relation to the event will be refunded. Please note – Due to lead times, event T-shirts may have been ordered, so the cost of T-shirt is non-refunable. The club will post T-shirts to all entrants.

Competitors & families who are unwell or have possible symptoms, or who have come into contact with a known case of Covid-19 are encouraged not to travel to the event, and *Club*> will offer a full refund less the cost of T-shirt.

CANCELLATION OF THE REGATTA

The organizing authority reserves the right to cancel the regatta completely by written notification to each yacht via email to the e-mail address provided on the Entry Application.

In the event of cancellation of the regatta:

a. In the event the regatta is cancelled, a refund in whole or part will be limited to payments made or due for the entry fee only.



b. This Agreement in respect of this regatta will be terminated forthwith; and each yacht, owner and captain hereby expressly agree that no claim of any nature whatsoever against the organizing authority will be permitted or entertained and each yacht, owner and captain hereby expressly undertakes to indemnify the organizers in respect of any claim brought by anyone associated with them and/or their yacht and any costs incurred by the organizers in relation to such claim.

POSTPONEMENT OF THE REGATTA

The organizing authority reserves the right to postpone the regatta by written notification to each yacht via email to the e-mail address provided on the Entry Application.

In the event of postponement of the regatta:

a) In the event the regatta is postponed to another date in 2022 no refund of the entry fee shall apply regardless if the yacht participates or not in the rescheduled date.

CANCELLATION OF REGATTA.

The organising authority reserves the right to postpone, or cancel the regatta completely by written notification to each yacht, via email to the contact provided on the Entry Form.

- a) In the event that the regatta is postponed or abandoned for reasons beyond the organisers control, or a Pandemic, a 100% refund.
- b) This Agreement in respect of this regatta will be terminated forthwith; and
- c) Each entrant hereby expressly agree that no claim of any nature whatsoever against the organising authority will be permitted or entertained and each entrant hereby expressly undertakes to indemnify the organisers in respect of any claim brought by anyone associated with them and/or their yacht any costs incurred by the organisers in relation to such claim.

EVENT CANCELLATION

In the event of cancellation due to any causes outside of the Organising Authority's control, all efforts will be made to reimburse Entry fees minus any Event associated cost already incurred that are not recoverable.
